

MARONI'S PIZZA HOUSE
ROOM RESERVATION AGREEMENT

EFFECTIVE JANUARY 1, 2014

ROOM:

OUR 50-PERSON SEATING AREA IS AVAILABLE, FOR RESERVATION, TO ALL CUSTOMERS. THIS AREA IS LOCATED AWAY FROM OUR MAIN COUNTER, IN THE REAR OF THE STORE. THE ROOM IS AVAILABLE 5 DAYS A WEEK (EXCEPT MONDAYS AND FRIDAYS), TWICE A DAY, AND LIMITED TO A 2-HOUR TIME BLOCK PER RESERVATION. TYPICALLY, RESERVATION TIMES RUN FROM 2:00PM TO 4:00 OR FROM 5:00PM TO 7:00PM. THERE ARE NO LIMITATIONS TO THE TYPE OF EVENTS THE ROOM CAN BE RESERVED FOR, HOWEVER, ROOM ACTIVITIES SHOULD NOT INTERFERE WITH OR DISRUPT NORMAL OPERATIONS, CUSTOMER FOOT TRAFFIC OR "EAT-IN" CUSTOMERS SEATED IN THE FRONT OF THE STORE.

FEE:

THE RESERVATION FEE IS \$40.00 - WHICH WILL BE DUE AT THE TIME THIS AGREEMENT IS MADE. THE RESERVATION FEE IS NON-REFUNDABLE – NO EXCEPTIONS. THE FEE INCLUDES THE USE OF THE ROOM, REST ROOMS, TABLES, CHAIRS, JUKEBOX ENTERTAINMENT, HIGHCHAIRS, PLATES, CUPS AND NAPKINS. PAYMENTS WILL BE CASH ONLY – THIS INCLUDES RESERVATION FEES AND ALL COSTS INCURRED DURING AND THROUGHOUT YOUR EVENT.

FOOD, DRINKS & ENTERTAINMENT:

OUTSIDE FOOD OR DRINK WILL NOT BE PERMITTED. ALSO, DJ ENTERTAINMENT IS NOT PERMITTED. OTHER ENTERTAINMENT MAY BE ALLOWED, HOWEVER, MUST BE DISCUSSED AT THE TIME THIS AGREEMENT IS MADE.

PARKING:

THERE ARE NO PARKING PRIVILEGES ASSOCIATED WITH THIS AGREEMENT. PARKING SPACE IS TO BE USED BY ALL MARONI'S PIZZA HOUSE CUSTOMERS. ON-STREET PARKING IS AVAILABLE TO EVERYONE, HOWEVER, WE ASK THAT YOU DO NOT BLOCK OTHER DRIVERS AND OBEY ALL TRAFFIC LAWS WHEN PARKING YOUR VEHICLE.

SMOKING:

THE ENTIRE BUILDING WILL BE SMOKE FREE WITHOUT EXCEPTION. SMOKING WILL PERMITTED OUTSIDE THE BUILDING AT LEAST 15 FEET FROM ANY BUILDING ENTRANCE.

DECORATIONS:

YOU MUST BRING YOUR OWN DECORATIONS, ALTHOUGH, SOME DECORATIONS MAY BE PRESENT UPON YOUR ARRIVAL. DECORATIONS SHOULD BE APPROPRIATE AND NON-DISTRACTING TO OTHER CUSTOMERS. DECORATIONS MAY BE HUNG, HOWEVER, DONE IN A WAY THAT WILL NOT CAUSE DAMAGE TO THE PROPERTY. YOU MAY BE HELD RESPONSIBLE FOR ANY DAMAGE OR LOSSES INCURRED THROUGHOUT THE DURATION OF YOUR EVENT. THE ROOM MUST BE RESTORED TO THE CONDITION FOUND.
